## ***HOW DO I APPLY FOR LEGAL ASSISTANCE AT THE CLINIC?***

Come to the legal clinic as scheduled each month with proof of your income. Applicants are interviewed on a first come first serve basis. You will be interviewed by a volunteer paralegal to determine your financial eligibility. Then a volunteer attorney will talk with you about your legal problem.

## ***WHO IS ELIGIBLE FOR THE FREE LEGAL CLINIC?***

To be eligible for the legal clinic you must:

- Meet the federal income guidelines which are based on family size
- Have the type of case Legal Aid accepts
- Live in the county in which the clinic is being held

## ***WHAT KIND OF CASES ARE INTERVIEWED AT THE CLINIC?***

- Consumer
- Education
- Employment
- Estate Planning
- Family
- Landlord/tenant
- Public Benefits

## ***HOW MUCH DO I PAY FOR LEGAL AID SERVICES?***

The services are free. Attorneys from the local bar associations volunteer their time to provide free advice and/or representation. However, if your case is accepted you may be required to pay filing fees and court cost.

## ***HOW WILL I KNOW IF MY CASE IS ACCEPTED?***

Usually, within 14 days after your interview, you will be informed by letter if your case is accepted. If your case is considered an emergency, you will be notified as soon as possible.
